Records of National Guard Service in other states can be obtained by writing the respective state adjutant general. Also considered for purchase is service documented by State of Ohio records or National Guard unit records.
- If you have service with a reserve component of the regular armed services or Coast Guard, please provide OP&F with a copy of your Point Summary Statement.
