- As of 10/28: \$18.768 billion
- End of September value: \$19.0 billion

## 1/1/2024 ACTUARY REPORT

• Our actuary, CavMac delivered our annual actuarial valuation earlier today and reported our funding period increased slightly to 29.77 years, but still within the state-mandated 30 years.

## **CLARIFICATION ON WELLCARE Rx PLAN**

- We have had questions recently about the availability of a Wellcare prescription drug plan for Medicare retirees that was available through Alight in 2024, but that is no longer listed for 2025.
- Although it is not listed as an option, those members who were previously enrolled in this plan will continue to be able to keep that coverage in 2025 and no action is needed other than continuing to pay the premium where applicable. If already enrolled, this counts as "checking the box" for stipend eligibility.
- If you decide to enroll in a WellCare plan or any other prescription drug plan outside of Alight, you must maintain an enrollment in a medical plan through Alight to keep your stipend.

#### Board of Trustees 140 East Town Street, Columbus, Ohio October 30, 2024

- Medicare-eligible members can remain eligible for the OP&F stipend as long as they maintain either a medical or prescription program through Alight.
- Please be aware of calls that encourage enrollment in a plan you are not familiar with. Medicare retirees must only make changes through Alight.

## OPEN ENROLLMENT SEASON

- Open enrollment for pre-65 retirees begins on Friday, Nov. 1. For Medicare retirees open enrollment began Oct. 15.
- Alight now offers counseling sessions on plan choices for all retirees, not just Medicare-eligible members.
