# **B.** Federal Legislative Update:

Ms. Mary Beth Foley provided a summary on the "Fraud and Abuse – Removal of Safe Harbor Protection for Rebates Involving Prescription Pharmaceutical" The summary of the analysis of HHS proposal to pass on drug discounts directly to consumers. This rule would support the exchange model we currently have in place. However, the rule arguably undercuts the self-funded and fully insured models of insurance. Exclusivity in contracting is the cornerstone of many discount drug programs enjoyed by group plans, as you recall from our deep discounts negotiated with UHC. It is a mixed bag for us really, as active employee plans benefit from the current framework through employer negotiations on pharma pricing, but it helps retired members with individual contracts. We will follow this rule closely for impacts on OP&F members and send comment letters when necessary.
