<u>Vacation buyback program - The vacation buyback program is voluntary benefits allowing the employees to cash-in unused vacation time at their current base wage rate. 42 employees took advantage of the program.</u>

<u>Sick buyback program - The sick buyback program is an automatic benefit buying back 120 unused sick hours from employees with 600 or more unused sick hours as of a cutoff date in December. 37 employees were eligible.</u>

<u>Merit</u> - Merit spending for 2018 was approved at 3% of staff base wages and the top performer budget was approved at 1%.
